**ORDER AUTHORIZING, BUT NOT DIRECTING, THE DEBTORS TO PAY  
PREPETITION COMPENSATION TO TACTION FOR THE BENEFIT OF THE  
THIRD PARTY CALLERS**

Upon the Debtors' Motion, dated December 14, 2005, for an order authorizing, but not directing, the Debtors to pay prepetition compensation to Taction for the benefit of the Third Party Callers; and it appearing that the Court has jurisdiction over the subject matter of the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that this is a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates and their creditors; and it appearing that notice of the Motion was sufficient, and no other or further notice need be provided; and after due deliberation and cause appearing therefor;

**IT IS HEREBY ORDERED THAT:**

1. The Motion is granted.
2. The Debtors are authorized, but not directed, to honor and pay the Unpaid

Commissions to Taction for the benefit of the Third Party Callers.

3. The Debtors are authorized, but not directed, to honor and pay any Commission Reconciliation Amount to Taction for the benefit of the Third Party Callers.

4. The Debtors are authorized and empowered to take all actions and execute all documents or refrain from any actions necessary or appropriate to implement the relief granted in this Order.

5. Notwithstanding the possible applicability of Bankruptcy Rules 6004(g), 7062, 9014, or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

6. In accordance with this Order and any other order of this Court, the Debtors are authorized, but not directed, to pay all processing fees associated with, and all costs incident to, payment of the Third Party Caller Commissions.

7. The requirement set forth in Rule 9013-2 of the Local Bankruptcy Rules for the District of Maryland that any motion or other request for relief be accompanied by a memorandum of law is hereby deemed satisfied by all contents of the Motion.

8. This Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.

9. Debtors' counsel or noticing agent shall serve a copy of this Order upon the below attached Order Service List.
