

Statement of Financial Affairs

General Notes

Note 1: The Statement of Financial Affairs (the “Statement”) has been prepared by the Debtor’s management and is unaudited. The Debtor reserves all of its rights respecting such credits, allowances and other adjustments.

Note 6: The Debtor estimates that prior to October 16, 2005, it accrued certain current expenses and other long-term liabilities that either are not payable at this time or have not yet been reported and, therefore, are not otherwise set forth in the Statement. The accrued liabilities, for which the Debtor has accrued reserves, relate to, among other things, workers’ compensation plans, vacation policies, litigation, environmental programs and federal, state and local taxes.
